- Assist with interviewing potential staff members

Cost & Payment Options:

Invoice **MUST** be paid before service is rendered based on the agreed paying option. If payment is late or returned for any reason, it will result in automatic termination of services.

Option 1: Monthly

- **Deposit: \$8,500 non-refundable**

Payment will be due on the first of every month and late on the third of every month.

Option 2: 1st and the 15th

- **Deposit: First payment. \$4,250 non-refundable**

Your deposit covers your first payment, and your next payment will be due on the next due date.

Option 3: Weekly

- **Deposit: First weekly payment \$2,125**

Remaining balance will be invoiced every Friday.

If for any reason a refund is needed, it will be deducted from the next invoice. Refunds will NOT be issued for situations and circumstances out of the control of Mr. Ty. These things are but not limited to acts of God, pandemic, facility/maintenance issues, unpleased, budget change, etc.
